Thank you for the inquiry of Sep. 03, 2009, to resolve your account with the IRS.

We received your payment of \$110.00 and credited it to your account. You still have a balance due of penalties and interest. This is not exempt from the collection process.

We've provided a general explanation of the possible penalties and/or interest included in the current balance due on your account. **** Paying Late -- IRC Section 6651(d) ****

Initially, the penalty is 1/2% of the unpaid tax for each month or part of a month the tax isn't paid.

If we issue a Notice of Intent to Levy and the balance due isn't paid within 10 days from the date of the notice, the penalty increases to 1% a month.

The penalty can't be more than 25% of the tax paid late.

**** Filing and Paying Late -- IRC Section 6651 ****

We charge a 5% combined penalty of 4 1/2% for filing late and 1/2% for paying late when a return is filed late and the tax is not
